

# COMMUNITY GUIDELINES

## 1. OUR MISSION

SpicyDate exists to help people build real-life connections through dating, social experiences, events, communities, and shared activities.

We want SpicyDate to be safe, respectful, authentic, and enjoyable for everyone.

SpicyDate is built on trust, authenticity, safety, and respect. We expect all users to engage honestly, respect personal boundaries, follow applicable laws, and contribute positively to the community.

Violations of these Community Guidelines may result in content removal, feature restrictions, account suspension, or permanent removal from the Platform.

By using SpicyDate, you agree to follow these Community Guidelines in addition to our Terms of Use.

## 2. RESPECT OTHER PEOPLE

You must treat other users with respect, dignity, and consideration.

### Do not:

- Harass others
- Bully others
- Intimidate others
- Threaten others
- Stalk others
- Shame or humiliate others
- Send unwanted sexual messages or sexually explicit content
- Repeatedly contact users who have expressed disinterest or blocked communication
- Use hate speech or discriminatory language
- Encourage violence, self-harm, or illegal activity
- Share another person's private information without consent
- Respect personal boundaries, consent, and individual decisions at all times.

## 3. BE AUTHENTIC

Be yourself and represent yourself honestly.

### Do not:

- Create fake profiles
- Pretend to be another person
- Use stolen, misleading, or unauthorized photos
- Misrepresent your age
- Misrepresent your identity
- Misrepresent your relationship status
- Provide false verification information
- Create accounts for fraudulent, deceptive, or abusive purposes
- Create multiple accounts to evade restrictions or enforcement actions
- Mislead users about events, campaigns, fundraising activities, businesses, products, services, or opportunities
- Impersonate businesses, organizations, brands, public figures, or other users

Authenticity and honesty are essential for building trust within the SpicyDate community.

We may remove content, restrict features, suspend accounts, revoke verification status, or permanently remove users who engage in deceptive or fraudulent behavior.

## 4. NO SEXUAL SERVICES OR COMPENSATED INTIMACY

SpicyDate is not an escort service, prostitution platform, or transactional dating platform.

### You may not:

- Offer sexual services
- Request sexual services
- Promote escort services
- Sell intimate services
- Exchange money for intimacy
- Exchange gifts for sexual activity
- Exchange event participation for sexual activity
- Exchange support payments for companionship
- Request, imply, or expect sexual activity in exchange for gifts, payments, tips, crowdfunding contributions, subscriptions, support, or any other form of value
- Use the Platform to facilitate prostitution, escort services, sugar arrangements involving payment for intimacy, or any similar activity

Any account involved in these activities may be restricted, suspended, reported to relevant authorities where required by law, and permanently removed from the Platform.

## 5. NO EXPLOITATION OR COERCION

All interactions on SpicyDate must be voluntary.

### Do not:

- Manipulate users financially
- Blackmail users
- Threaten users
- Coerce users into unwanted activities
- Demand gifts
- Demand money
- Demand support payments
- Demand crowdfunding contributions
- Demand participation in events or campaigns
- Pressure users into meetings, relationships, communication, or personal interactions
- Exploit vulnerable individuals for financial, emotional, romantic, or personal gain

Users must be free to make their own decisions without pressure, intimidation, manipulation, or coercion.

Accounts involved in exploitation, coercion, harassment, financial abuse, or manipulative behavior may be restricted or permanently removed.

## 6. KEEP EVENTS SAFE

Hosts are responsible for the Events they create and organize.

### Hosts must:

- Provide accurate and complete event information
- Clearly describe activities, requirements, costs, and expectations
- Follow applicable laws and regulations
- Use appropriate and reasonably safe venues
- Treat participants with respect
- Communicate honestly with participants
- Obtain any permits, licenses, waivers, or approvals required by law
- Take reasonable steps to promote participant safety

### Hosts may not:

- Create fake events
- Create misleading or deceptive events
- Create unsafe events
- Create illegal events
- Misrepresent costs, activities, attendance, venues, or event details
- Use events to facilitate prohibited activities
- Use events to solicit sexual services, escort services, or unlawful transactions

Participants attend Events voluntarily and at their own risk.

Hosts are solely responsible for obtaining any insurance, licenses, permits, certifications, waivers, or approvals required for their Events under applicable law.

SpicyDate does not organize, supervise, inspect, endorse, or guarantee any Event, Host, venue, activity, or participant.

## 7. ACCEPTABLE CONTENT

### You may share:

- Dating profiles
- Photos
- Stories
- Experiences
- Travel content
- Event content
- Educational content
- Lifestyle content
- Creative content
- Community-related content

Content must be lawful, respectful, authentic, and consistent with these Community Guidelines.

### Do not post content that:

- Violates applicable laws
- Promotes criminal activity
- Contains fraud, scams, or deceptive information
- Contains harassment, threats, hate speech, or abuse
- Promotes violence or self-harm
- Violates another person's privacy or legal rights
- Infringes intellectual property rights
- Contains sexually exploitative material
- Contains child sexual abuse material or any sexual content involving minors
- Promotes prostitution, escort services, or sexual services
- Misleads users regarding Events, Campaigns, Gifts, fundraising activities, businesses, products, or services

SpicyDate may remove content that violates these Community Guidelines and may restrict or terminate accounts responsible for repeated or serious violations.

## 8. PROHIBITED CONTENT

You may not post, upload, publish, share, distribute, promote, or facilitate content that includes:

- Child exploitation
- Sexual content involving minors
- Terrorism or extremist content
- Promotion of violence
- Graphic violence
- Criminal activity
- Fraud, scams, or deceptive schemes
- Drug trafficking or illegal drug sales
- Illegal weapon sales
- Copyright infringement or intellectual property violations
- Malware, viruses, or harmful software
- Prostitution, escort services, or sexual services
- Human trafficking or exploitation
- Non-consensual intimate images or private information
- Content that promotes self-harm or suicide
- Content intended to deceive users about Events, Campaigns, Gifts, fundraising activities, businesses, products, or services

Such content may be removed immediately and may result in account restrictions, suspension, permanent account termination, reporting to payment providers, or referral to law enforcement authorities where required by law.

## 9. ADULT CONTENT

SpicyDate is an adult platform intended only for users who are at least 18 years old.

However, the Platform is not intended for pornography, adult entertainment, or sexually explicit content.

### Users may not post, upload, share, distribute, stream, sell, or promote:

- Pornographic content
- Explicit sexual content
- Graphic nudity primarily intended for sexual gratification
- Sexual exploitation
- Non-consensual intimate imagery
- Content involving sexual activity in exchange for money, gifts, support, services, or other benefits
- Content promoting prostitution, escort services, or sexual services
- Content that sexualizes minors in any way
- Sexually exploitative or abusive material

Non-explicit dating, lifestyle, travel, event, relationship, wellness, fitness, fashion, artistic, or educational content may be permitted where consistent with these Community Guidelines and applicable laws.

Recipients are under no obligation to respond, communicate, meet, provide services, continue relationships, attend Events, or fulfill expectations created by a sender. SpicyDate reserves the right to remove content or restrict accounts where content is determined to be sexually explicit, exploitative, unsafe, or inconsistent with the intended purpose of the Platform.

## 10. GIFTS, SUPPORT AND CROWDFUNDING

Gifts, tips, support payments, and contributions are voluntary.

All Gifts, support payments, and crowdfunding contributions are final unless otherwise required by applicable law.

Users may not use the Platform to solicit, request, encourage, direct, or facilitate payments outside Platform-approved payment methods where such functionality is available.

Sending a Gift, tip, support payment, crowdfunding contribution, or any other form of financial support does not entitle you to:

- Replies
- Attention
- Communication
- Meetings
- Relationships
- Dates
- Event invitations
- Priority treatment
- Personal access
- Sexual activity
- Any guaranteed outcome

Users must not use Gifts, support, contributions, or financial assistance to pressure, manipulate, influence, coerce, or control another user.

Recipients are under no obligation to respond, communicate, meet, provide services, continue relationships, attend Events, or fulfill expectations created by a sender.

Any attempt to exchange financial support for sexual activity, companionship, personal relationships, exclusive attention, or other prohibited benefits may result in account restrictions or permanent removal from the Platform.

## 11. REPORTING VIOLATIONS

Help us keep the community safe.

Please report users, content, Events, Campaigns, or activities that involve:

- Fraud or scams
- Harassment or bullying
- Threats or intimidation
- Impersonation or fake profiles
- Sexual exploitation
- Prohibited sexual services
- Unsafe behavior
- Criminal activity
- Hate speech or discrimination
- Violence or threats of violence
- Self-harm promotion
- Suspicious financial activity
- Misleading Events or fundraising campaigns

SpicyDate reviews reports and may investigate, remove content, restrict features, suspend accounts, terminate accounts, refuse payouts, or take other actions where appropriate.

Submitting false, abusive, or intentionally misleading reports may also result in enforcement action.

## 12. ENFORCEMENT

Violations of these Community Guidelines, our Terms of Use, applicable laws, or Platform policies may result in one or more enforcement actions, including:

- Content removal
- Warning notices
- Reduced visibility of content or profiles
- Feature restrictions
- Event removal
- Campaign removal
- Monetization restrictions
- Payment holds or payout restrictions
- Temporary account suspension
- Permanent account termination

SpicyDate may investigate suspected violations and determine appropriate enforcement actions at its discretion, taking into account the nature, severity, frequency, and impact of the violation.

Serious violations may be reported to payment providers, regulatory authorities, or law enforcement agencies where required by law or reasonably necessary to protect users, third parties, or the Platform.

## 13. OUR RIGHT TO ACT

We may investigate behavior both on and off the Platform where such conduct may affect user safety, platform integrity, legal compliance, community trust, or the reputation of the Platform.

We reserve the right to take action against conduct that violates the intent, spirit, or purpose of these Community Guidelines, even if the conduct is not specifically described or prohibited in these Guidelines.

Nothing in these Community Guidelines limits SpicyDate's ability to take reasonable action to protect users, the Platform, third parties, or comply with applicable laws.

Failure to investigate, remove, restrict, or act upon any violation does not constitute approval, endorsement, or waiver of SpicyDate's rights under these Community Guidelines.
